HOW TO TRANSACT BUSINESS

With the Department of Telephones

APPLICATIONS FOR NEW SERVICE — CHANGES IN LOCATION — TERMINATION OF SERVICE

All matters relating to new telephone service, removals, termination of service, directory listings, adjustment of accounts, collection of bills, etc., are handled at the Business Offices of the Department.

CHANGES IN DIRECTORY LISTINGS

This telephone directory is issued regularly once a year. Notification as to new listings, changes or corrections should be made to the Local Office at once.

DIRECTORY ADVERTISING

For information as to space or rates for Directory advertising, please communicate with Local Business Office.

TERMS AND CONDITIONS

Under Which Telephone Service is Furnished

USE OF TELEPHONE

1. The service furnished is for the exclusive use of the subscriber and members of the subscriber's household or the subscriber's employees upon the subscriber's business, and the subscriber shall not extend the use of the telephone to any other person, nor shall the subscriber transmit messages for any other person; and if a residence telephone is used for business or professional purposes the Department may charge therefor the rate charged for business or professional telephones. The residence telephone number of a subscriber may be advertised only in conjunction with the advertising of his business telephone number.

The Department will endeavor to keep the lines and instruments in good working order and undertakes to clear trouble or make repairs with all reasonable despatch, but does not guarantee uninterrupted service.

The right of the subscriber is to use the instruments and connecting lines where the Department may place them, but not elsewhere, under such rules as the Department may from time to time prescribe.

The use of obscene, profane or abusive language while using the telephone is strictly forbidden and service may be immediately discontinued for violation of this rule.

2. The instruments and all accessories connected therewith shall remain the property of the Department and the subscriber shall not remove, alter, or make any attachment thereto; and the subscriber agrees to compensate the Department on demand for any damage, loss or destruction of the Department's instruments and accessories whilst such instruments and accessories are in or upon the premises of the subscriber.

CONSTRUCTION

3. When it is necessary to erect poles or anchors in order to carry the wires from the main telephone line on the road allowance or street to the applicant's premises, such poles and anchors in connection therewith will be supplied and erected by the Department at the expense of the applicant.

CHARGES — HOW PAID

4. All charges for installation, moves, and monthly rentals shall be paid in advance, which shall entitle the subscriber to service with all subscribers connected to the same exchange. Regular toll rates will be charged for all service to points outside of the exchange.

5. Subscribers shall pay the installation charges, first rental instalment (and construction charges, if any) strictly in advance. Excess mileage charge will be added if outside of exchange limits. If subsequent rental accounts remain unpaid after the 15th of the month, service shall be discontinued and no rebate or reduction shall be allowed for such interruption to service.

6. Subscribers shall pay monthly, at schedule rates, for all messages and conversations over the Long Distance lines. If said accounts remain unpaid after the 15th of the month, further credit shall be refused until account is paid.

7. Subscribers shall pay promptly, upon presentation of account, all charges for other miscellaneous items. If these charges are not paid within 15 days, service shall be discontinued.

COMPLAINTS RE LONG DISTANCE SERVICE

8. While the Department will carefully consider complaints in connection with toll service at any time received, it would be appreciated if subscribers would make such complaints immediately after conversation has taken place.

VACATION ALLOWANCE

9. Should a subscriber desire to have his Exchange Service temporarily discontinued, owing to the closing of his premises, he may do so without cancelling contract or having telephone removed, and, if arranged for in advance in writing, an allowance of two-thirds of the rate per month will be made for a period of not less than one month and not exceeding three months in any one year. Subscriber shall state, when making application, the period for which he expects to be absent and shall pay for this period in advance. Subscriber will notify the Department when he wishes service resumed, either in writing or by calling at the office and signing re-connect order. Owing to the fact that Multi-Party Line Telephones cannot be disconnected without a special trip being made to their location, this regulation will not apply to Multi-Party Line Service.

MOVES

10. The telephone is first located where the subscriber directs and must not be moved or interfered with. When the subscriber desires to have the telephone moved to any other location, notice in writing should be given to the local office, at least ten days before the change is desired. The work will then be done as promptly as possible at regular charges.

JOINT USER SERVICE

11. A joint user is a person, firm or corporation who shares the subscriber's exchange service in accordance with tariff provisions. To facilitate this use of service, a directory listing is included.

Business joint user—one-third of business wall-set rate.

Residence joint user—50c per month.

CANCELLATION OF SERVICE

12. Subscribers giving up service must notify the Department in writing, or call at office and sign "Take Out" order. Failing to do this, subscriber will be liable for all charges up to date instrument is removed or taken over by a new subscriber.

DIRECTORIES

13. The Department of Telephones assumes no liability on account of errors in or omissions from its directories. Telephone directories are and remain the property of Alberta Government Telephones, and subscribers will only receive free issue of the particular directory published covering the district in which their listing appears. Copies of other directories published by the Alberta Government Telephones may be obtained from the Directory Department, at Calgary, upon payment of the regular purchase price. Free issues are printed for the exclusive use of the Department's patrons and are loaned to its subscribers. All persons are cautioned against reproducing their contents, which are fully protected by copyright. Subscribers must not use any binder, holder or other attachments, except as provided by the Department.

TELEPHONE NUMBERS

14. A subscriber's telephone number is not a part of the application for service, but numbers will only be changed when absolutely necessary or for the betterment of the service.

LONG DISTANCE SERVICE

RULES AND REGULATIONS

(a) If you desire Station-to-Station service, call "Long Distance" in the regular way. When the Long Distance operator answers, give the number of the telephone from which you are speaking and say, "I want to speak to (telephone number) (terminating office) or, if the telephone number desired is not known, you will obtain the Station-to-Station rate by saying to our Long Distance operator, "I want to speak to (called party's residence or office), (terminating office). Anyone at that number will do."

(b) If you desire to reach a particular person at a certain telephone number or address, call "Long Distance" in the regular way. When the Long Distance operator answers give the number of the telephone from which you are speaking, also your name and initials, together with the initials and name of the particular person desired and the city or town where he can be located.

(c) If you desire to place an appointment or messenger call, or transmit a written message or telegram, call "Long Distance" in the regular way and give your order as heretofore.

Long Distance Charges—All rates quoted are for an initial period of three minutes. For overtime beyond the initial period a proportionate charge is made per minute.

LONG DISTANCE SERVICE — Continued.

Long Distance Tolls will be charged to the subscriber from whose instrument the Long Distance Call is placed.

Night Rates—Reduced rates are in effect from 6:00 p.m. to 4:30 a.m. and all day Sunday.

Note:—In no case shall the Night Rate be less than 25c. for the initial period, unless the Day Rate is less, in which case the Day and Night Rates shall be the same.

Reversal of Charges—All charges will be made against the Originating Office except those messages for which the receiving party expressly agrees to pay. The assent of the receiving party to a reversal of charges should be obtained before the connection is established.

Messenger Service—Upon request, and the prepayment of reasonable charges, a messenger will be sent when possible to notify a non-subscriber to come to any Public Pay Station.

When a particular person is desired, the Long Distance operator must be so advised when the call is placed, otherwise charges will be made from the time connection is established with the telephone desired, whether the party required is obtained or not.

COMPLAINTS: Complaints regarding telephone trouble and unsatisfactory service should be made to the Local Manager, Agent or Chief Operator at the office concerned, and if not rectified within a reasonable time, the matter should be referred to the General Traffic Superintendent at Edmonton.

If there is anything about our rates and practices you do not fully understand, please call your Local Manager or Chief Operator and they will be glad to explain.

MANUAL TELEPHONE

Consult the Telephone Directory for the correct number before you make a call. Do not trust to your memory.

Ask for "Information" if the person or firm you wish to call is not listed in the Directory.

1. **To Call the Operator** give one long ring before removing the receiver from the hook and then hold receiver to the ear.

2. **When the Operator Replies** by saying, "Number?" give the number of the subscriber's telephone desired, slowly and distinctly.

Example:—"1429" should be pronounced "one four two nine."

"175" should be pronounced, "One - seven five."

3. **Face the Transmitter** with the lips almost touching the mouthpiece. Speak naturally, distinctly and not too rapidly.

4. **Keep the Receiver to the Ear**, and the Operator, after repeating the number, will connect you with the subscriber called for. If the desired line is found to be in use the operator will report "Line Busy."

5. **When You Have Finished Talking** place the receiver on the hook, small end

up, and give a short ring. This gives the operator a signal to disconnect and you are then in a position to call another number or to be called.

NOTE:—At Grande Prairie (Common Battery Exchange) no ringing, except by rural line subscribers, is necessary. Simply remove receiver from hook and in all other respects proceed as instructed above, placing the receiver on the hook when conversation is finished.

6. **Do Not Use the Telephone** during a thunderstorm.

7. **Rural Line Subscribers** should limit their conversation to Five Minutes duration and must not "listen in" to conversation not intended for them, as it interferes with the Service.

Complaints:—Complaints regarding telephone trouble and unsatisfactory Service should be made to the Local Manager, Agent or Chief Operator at the Office concerned, and if not rectified within a reasonable time, the matter should be referred to the General Traffic Superintendent at Edmonton.
