Department of Railways and Telephones

TERMS AND CONDITIONS UNDER WHICH TELEPHONE SERVICE IS FURNISHED

1. Telephone instruments and connecting lines are furnished to subscribers to be used in accordance with the rules as prescribed by the Department from time to time, and are to be used only by the subscriber, his agents or employees when engaged upon his business and must not be used for transmitting, receiving or delivering any message or communication in respect of which a consideration has been or is to be paid by any other party, except as permitted by the rules of the Department, nor used in any way in competition with the telephone business conducted by the Department. Subscribers will not be allowed to transfer their telephone number, service, or contract to any other party, unless arranged for in advance by a duly authorized official of the Department.

2. | The lines and instruments over which the service is furnished remain the property of the Government and subscribers must not use or permit any electrical or mechanical connection or apparatus being made with the said lines or instruments without the written consent of the Department.

3. When it is necessary to erect poles or anchors in order to carry the wires from the main telephone line on the road allowance or street to the applicant's premises, such poles and anchors in connection therewith will be supplied and erected by the Department at the expense of the applicant, or if arranged for in advance in writing, the applicant may furnish and erect such poles and anchors in accordance with the specifications and regulations of the Department.

4. The initial installation period shall be one year for Exchange service and three years for Rural Line service, unless otherwise specified, and contract shall continue in force thereafter until cancelled by the subscriber or the Department by giving written or printed notice ten days in advance of the termination of any subsequent rental period of his or its intention so to do.

5. All rentals shall be paid in advance, which shall entitle the subscriber to service with all subscribers connected to the same exchange. Regular toll rates will be charged for all service to points outside of the exchange.

6. Subscribers shall pay the first rental instalment (and construction charges, if any) strictly in advance. If subsequent rental accounts remain unpaid after the 25th of the month, service may be discontinued and if still remaining unpaid after the end of the month service shall be discontinued and a charge of \$1.00 shall be made to reconnect service; no rebate or reduction shall be allowed for such interruption to service.

7. Subscribers shall pay monthly, at schedule rates, for all messages and conversations over the Long Distance lines. If said accounts remain unpaid after the 15th of the month, further credit may be refused until account is paid.

8. No allowance will be made on complaint of inefficient Long Distance service unless such complaint be made to Chief Operator, immediately after conversation has taken place.

9. Subscribers shall pay promptly, upon presentation of account, all charges for moving instruments and other miscellaneous items. If these charges are not paid within 15 days, service may be discontinued.

10. If Exchange subscriber desires to dicontinue the service before the expiration of the initial installation period, he will be required to pay for the service rendered on the basis of short term rates.

11. If Rural Line subscriber desires to discontinue the service before the expiration of the initial installation period, he will be required to pay the regular rate up to and including current rental period and one-half the regular rate for the unexpired portion of initial installation period.

12. The short term rate shall be two-twelfths of the annual rate for the first month or fraction thereof, and one-twelfth of the annual rate for each succeeding month or fraction thereof, plus the total cost of making the installation.

Excess mileage charge will be added if outside of exchange limits.

13. After one year's continuous service, should a subscriber desire to have his **Exchange Residence Service** temporarily discontinued, owing to the closing of his residence, he may do so without cancelling contract or having telephone removed and, if arranged for in advance in writing, an allowance of one-half of the rate per month will be made for a period not to exceed three months in any one year. Subscriber shall state, when making application, the period for which he expects to be absent and shall pay for this period in advance. Subscriber will notify the Department when he wishes service resumed.

14. The telephone is first located where the subscriber directs and must not be moved or interfered with. When the subscriber desires to have the telephone moved to any other location, he is requested to fill in the blank form in back of Directory and forward same to local agent, at least ten days before change is desired. The work will then be done as promptly as possible at the expense of the subscriber.

15. If a telephone installed for service at the residence rate be used for the purposes of a business or profession, or otherwise than for the usual requirements of a residence, the Department may charge the business rate for such service without regard to the date to which the subscriber has paid for service at the residence rate. This also applies to subscribers, for residence service only, who advertise or use their telephone number in connection with their business or profession.

16. The Department will endeavor to keep the lines and instruments in good working order and undertake to clear trouble or make repairs with all reasonable despatch but does not guarantee uninterrupted service.

17. A subscriber's telephone number is not a part of the application for service, but numbers will only be changed when absolutely necessary or for the betterment of the service.

18. The use of profane or improper language while using the telephone is strictly forbidden and service may be immediately discontinued for violation of this rule.

DIRECTORY REGULATIONS

This Directory is the property of the Alberta Government and is loaned to telephone subscribers for their use, to be retained until the delivery of the next issue. Subscribers are furnished free one copy for each instrument. Additional copies will be charged for, 25c per copy.

Copy for Directory Information will be closed on the following dates:-

January Issue December 1st

July Issue.....June 1st

No insertions, changes or corrections may be made after the date set for the closing of copy.

Each subscriber is entitled to one single line entry in the Alphabetical List without charge. Listings in bold type will be charged at the rate of Two Dollars per issue. By special arrangement any subscriber to Exchange Business Service may have the name of any company which he represents, or of any employee or agent, listed in Directory at a nominal charge of One Dollar per line per issue. A subscriber to Exchange Residence service may have the name of a bona fide member of his family listed in the Directory for One Dollar per line per issue. When it is desired to insert the name of a person not an actual member of the family, the charge will be Six Dollars per annum, which includes Exchange Service. Each business subscriber is entitled to one single line entry in light face type in the Classified Business Section without charge and additional classifications in light face type will be made at a charge of One Dollar per line per issue. Listings in bold type will be charged at the rate of Two Dollars per line per issue.

Subscribers are requested to report promptly to the Local Office, in writing, any errors which may appear in this Directory, so that same may be corrected in the next issue.

INSTRUCTIONS FOR USE OF AUTOMATIC TELEPHONE

CONSULT THE DIRECTORY IN ALL CASES BEFORE PLACING A CALL. DO NOT TRUST TO YOUR MEMORY

(1) Remove receiver from hook before operating dial.

(2) Bring the finger squarely to the finger stop.

IMPORTANT—When calling a number allow a slight interval to elapse between each figure.

(3) Face the instrument and talk in moderate tone directly into the transmitter.

(4) Do not move receiver hook or dial while talking, as this will disconnect you.

(5) Always hang up receiver for a short interval before making a second call, to allow the mechanism to release.

(6) Hang receiver on hook (small end up) when through talking, otherwise no one can obtain connection with your telephone.

(7) BUSY BUZZ. If, after calling a number, a buzzing sound is heard, it indicates that the number called for is busy.

EXAMPLE

To call M2300—Remove receiver from hook, place finger in finger hole M and pull dial down until finger reaches the finger stop; let dial rotate back; then in same manner pull 2-3-0-0.

Dial will rotate back. Do not interfere with this backward motion.

Place receiver to your ear. If the busy buzz is heard it indicates that M2300 is busy. This being the case, hang up the receiver and call again within a reasonable time.

At completion of conversation, hang receiver on hook, small end up.

You are now entirely disconnected and ready to call another number or to be called.

If a mistake is made in calling the correct number or if the dial is improperly operated, the receiver must be hung up before calling again. If connection is accidentally broken it should be restored by the calling party. When using an extension telephone, listen and speak before operating dial.

AUTOMATIC EXCHANGES

INFORMATION

Call Information for NUMBERS of New Subscribers, Changes, Long Distance Line Charges, New Toll Offices, etc.

TROUBLE

Complaints regarding Telephone Troubles should be reported to **Trouble Operator.** When reporting trouble give telephone number affected and its location, also state as accurately as possible just how trouble manifests itself. Try to be specific as incomplete information frequently causes delay in locating nature of trouble. If a line you are trying to call repeatedly tests "busy" notify trouble clerk, who will investigate whether same is caused by an abnormal condition on line or from use. If any line appears too busy for good service write to the Commercial Manager. Subscribers are requested not to engage Trouble or Information Clerks in conversation longer than necessary, as by so doing the clerk will be prevented from giving prompt attention to other patrons.

INSTRUCTIONS FOR USE OF MANUAL TELEPHONE

CONSULT THE DIRECTORY IN ALL CASES BEFORE PLACING A CALL. DO NOT TRUST TO YOUR MEMORY.

To call the Operator give one long ring before removing the receiver from the hook and then hold the receiver to the ear. When the Operator replies by saying "Number?" give the number of the subscriber's telephone desired, slowly and distinctly. At multi office exchanges first indicate the exchange desired by the prefixed letter and then pronounce the number by digits.

For example:- "M1429" should be pronounced "M one-four-two-nine."

At other exchanges pronounce the number desired by digits.

For example:-"175" should be pronounced "One-seven-five."

Keep the receiver to the ear, and the Operator, after repeating the number, will connect you with the Subscriber called for. If the desired line is found to be in use, the Operator will report "Line Busy."

When you have finished talking place the receiver on the hook, small end up, and give a short ring. This gives the Operator a signal to disconnect, and you are then in a position to call another number or to be called.

ANSWER THE CALLS ON YOUR TELEPHONE PROMPTLY BY ANNOUNCING YOUR TELEPHONE NUMBER.

Face the Transmitter with the lips almost touching the mouthpiece. Speak naturally, distinctly, and not too rapidly.

Call "Information" for subscribers or changes not found in this Directory.

NO NOT USE THE TELEPHONE DURING A THUNDER-STORM.

COMPLAINTS

Complaints regarding telephone trouble should be made to the Chief Operator at the office concerned and if not rectified within a reasonable time the matter should be referred to the Traffic Superintendent at Edmonton.

NOTICE



TO TELEPHONE SUBSCRIBERS AND THE PUBLIC

All employees of the Alberta Government Telephones whose duties require them to enter the premises of subscribers or others, are required to wear a badge similar to that illustrated above. The public is hereby notified to require all persons who desire to enter their buildings or premises for purposes in connection with the Telephone to exhibit their badges and note the numbers of the same. Any person claiming to be an employee of the Alberta Government Telephones, who is without this badge, should be refused admission and the Local Agent be notified at once by telephone.

LONG DISTANCE SERVICE

RULES AND REGULATIONS.

To make a Long Distance Call—Call "Long Distance" in the regular way. When the Long Distance Operator answers, give the number of the Telephone from which you are speaking, your own initials and name, the initials and name of the particular person desired and the city or town where he can be located.

Example—"Number M4567, J. H. Brown speaking. Get W. K. Jones at Edmonton. If he is not there I will speak to A. F. Smith."

Long Distance Charges—All rates quoted are for an initial period of three minutes. For overtime beyond the initial period a proportionate charge is made per minute.

Long Distance Tolls will be charged to the Subscriber from whose instrument the Long Distance message is sent.

Night Rates—From 19k to 7k (7 p.m. to 7 a.m.) a Night Rate of about one-half the day rate is in effect over the Long Distance Lines of the Government, except on business with Saskatchewan Government Telephones' points. In no case is the night rate less than 25 cents, unless the day rate is less, in which case the night and day rates are the same.

Reversal of Charges—All charges will be made against the Originating Office except those messages for which the receiving party expressly agrees to pay. The assent of the receiving party to a reversal of charges should be obtained before the connection is established.

Messenger Service—Upon request, and the prepayment of reasonable charges, a messenger will be sent when possible to notify a non-subscriber to come to any Public Pay Station.

When a Particular Person is Desired the Long Distance Operator must be so advised when the call is placed, otherwise charge will be made from the time connection is established with the Telephone desired, whether the party required is obtained or not.

Supervision by Private Branch Exchange Operators—The Long Distance Operator is held responsible for the supervision and timing of all messages and for the character of the service furnished. Supervision of connections by Private Branch Exchange Operators interferes with the service and such operators should not remain "cut in" on the line after the connection has been established.

Slot Machine Pay Station Service—Slot Machine Telephones have been installed by the Department, for the convenience of subscribers and the general public, in suitable locations throughout our cities.

Local conversations may be had from these Telephones at a charge of 5 cents for 5 minutes.

Long Distance service is furnished at regular tariff rates upon deposit of the amount of the initial charge (covering three minutes' conversation), the usual charges being made for excess time.

Non-Subscribers who desire to use subscribers' telephones should be referred to the nearest Public Pay Station.

Complaints regarding unsatisfactory Long Distance service should be made to the Chief Operator, and if not then rectified the matter should be referred to the Traffic Superintendent, Edmonton.

LONG DISTANCE RATES From Lethbridge

Some Pertinent Facts Relative to the Telephone Service We Furnish

When a telephone is installed in your residence it necessitates the Department furnishing you with more or less of its equipment, for instance: wire from the Exchange to your house, the telephone instrument, also the switchboard equipment reserved for you.

In addition to the above, the Telephone Department must spend approximately \$8.00 on your own premises for doing that which you do for yourself, at your own expense, when you instal water, gas or electricity.

The \$8.00 mentioned never comes back. This covers the cost of taking the installing crew to and from your place, the labor of putting the wires and the telephone in your house, the material used, wire, knobs, screws, nails, etc., none of which can be used again at any other place. There is no salvage on it. It is GONE.

Do you know of any other public utility furnishing you a personal service on your own premises which does as much as the Alberta Government Telephones at so little expense to you?

If you use electricity, you wire your own house, and buy your own fixtures.

When you use city water you pipe your premises from your front curb at your own expense. You furnish your own fixtures and pay for the plumbing, and if you fail to pay your bills promptly, your water is cut off.

When the waterpipes on your premises spring a leak you send for the plumber and foot the bill yourself. When your electric wiring goes bad or the lamps break, you pay for same. BUT when your telephone is in trouble, even inside your own house, you immediately send for the telephone man, and the Telephone Department pays the bill.

Notwithstanding that the cost of material has increased from 75% to 300%, the telephone rates have remained the same.

Is it then unreasonable that the Telephone Department should ask that you pay your bills promptly; that if we instal a telephone for you, you should guarantee to keep it a reasonable time, and if you request your telephone moved from one position to another, or from one address to another, is there any reason why you should not pay the expense involved in making the move?
